#### From the Desk of Director

It gives me great pleasure in presenting the Annual Report of the Indian Institute of Dalit Studies (IIDS) for the year 2010-11. The year has been full of challenges and opportunities.

As a recognition of our vision to undertake dedicated research on the development concerns of those who are excluded and discriminated in the Indian society on the basis of their caste, ethnicity, religion, physical disabilities, colour and gender. Since its inception in 2003 and the initial focus on addressing the development issues of Scheduled Castes (Dalits), IIDS has been striving to gradually diversify its research into new themes and cover new groups such as Scheduled Tribes, religious minorities, persons with disabilities, and women belonging to these groups as their experiences of exclusion and discrimination are different from Dalits. Accordingly, we reorganised our research into five thematic areas during the year and took focused measures to strengthen the activities under these areas. At the outset, we prepared status reports for Scheduled Tribes, Dalit Christians and Dalit Muslims for better understanding of their participation in social, economic and political spheres of development and overall wellbeing.

As part of this endeavour, IIDS completed six research studies in 2010-11 under the International NGO's Partnership Agreement Programme (IPAP), supported by Christian Aid, UK; launched "Dalit Asmita", a quarterly journal in Hindi aiming to promote literary work on Dalits and their struggle for identity,

emancipation and development; published five Working Papers and one book. Besides, as part of our dissemination and outreach activities, we organised four workshops and two national seminars and series of lectures, actively engaging with academia, policy makers, civil society organisations and research scholars.

No work or engagement on social exclusion is complete without the gender lens being applied. Although the fate of the Women's Reservation Bill continues to hang in uncertainty, yet the participation of women in institutions of democracy is fast gaining strength. IIDS did an analysis of Dalit women rights and citizenship in India, particularly with reference to institutions of politics and governance.

IIDS has made steady efforts to engage itself in policy oriented research with the objective of providing evidence based feedback to policy making in the country. As the process of formulating the 12th Five Year Plan was underway, IIDS continued to gather evidence and build perspectives on the gaps in the implementation of various national flagship schemes in relation to marginalised communities. It undertook a large field based study sponsored by UNICEF to understand the issues of inclusion in flagship schemes of Government of India relating to livelihood promotion, education, nutrition and health. These studies would provide a strong basis for intensifying the inclusionary development programmes in the 12th Five Year Plan and later plans.

With the objective of promoting scientific research and informed debate on issues of social inclusion and development on a wider scale, IIDS has committed to publish the "Journal of Social Inclusion Studies". Planning for the journal is underway and an Editorial Advisory Board comprising eminent scholars, policy

makers and social activists both from India and overseas has been constituted.

The year has been marked with the award of IDRC Think Tank Initiative grant to IIDS. This has made possible strengthening of human resource and organisational base of the Institute. We are committed to provide modern infrastructure and better service conditions to our employees. We have expanded our Research Advisory Committee to bring in multidisciplinary perspectives in research. We have also developed a vibrant community of researchers who are committed to jointly undertake research with IIDS to address the multidimensional issues of exclusion and discrimination; and to promote informed policy debates on the issues of inclusion and development.

Since IIDS undertakes research on unconventional and unexplored areas, it faces the challenge of developing appropriate research methodology due to lack of available literature, information and data on marginalised groups. Therefore, the key challenge before IIDS is to build an information base through field-based studies and fill up the gaps in the official data used for making the development policy for the marginalised groups.

Our partnership with UNICEF and Christian Aid, UK further intensified in the year with more research subjects being covered in IIDS research programmes. The IDRC Think Tank Grant to IIDS has provided a solid base for intensifying as well as diversifying our research programmes. The Research Councils of UK has recognised IIDS as a "Centre with Potential Excellence".

I would like to congratulate all the staff members, Board Members, Managing Trustee, Finance and Administrative Committee and Research Advisory Committee of IIDS for the achievement made by the Institute in 2010-11. We look forward to continuing our positive engagement with institutions of policy making and governance, academics, donor agencies, and also with civil society organisations in our mission to develop an inclusive society.

#### **Research and Publications**

#### **IDRC Think Tank Initiative Grant**

IIDS received Think Tank Initiative Grant initially for a period of four years for strengthening its organizational development, research and outreach. This grant has helped IIDS in recruiting new researchers, training of human resources, strengthening IT infrastructure, developing library and other infrastructure and expanding its research into new thematic areas.

# I. INTRODUCTION

Indian Institute of Dalit Studies (IIDS) was established in 2003 as a not-for-profit autonomous institution to undertake educational research and promote informed debate on the issues of social exclusion, discrimination, their consequences, and inclusive polices. It is one of the first research organisations in India to focus specifically on the development concerns of marginalised and socially excluded groups who suffer from exclusion on account of their group identity or social origin like caste, ethnicity, gender, religion, colour, disability, regional identity and other forms of social identities. These groups include former untouchables or Dalits, tribes, religious minorities like Muslims and Christians, women (particularly belonging to excluded groups), denotified, nomadic and semi-nomadic tribes and others.

#### Vision

Indian society is characterised by processes of social exclusion and discrimination in varying degrees, which involves denial of equal rights and entitlements to a number of excluded groups, resulting in high deprivation and poverty among these groups. IIDS recognises this aspect and envisions an 'inclusive society' with equal rights and entitlements to the excluded and discriminated groups. To this end, it strives to develop a 'body of knowledge' to understand the issues of poverty, human deprivation and human rights that are induced by exclusion. It also endeavours to suggest evidence based policies for a socially, economically and politically inclusive society with equal rights and entitlements to excluded and discriminated groups.

#### **Objectives**

- > To undertake interdisciplinary theoretical and empirical and applicationbased research on exclusion and discrimination faced by Dalits, tribes, religious minorities and women belonging to excluded groups and other similar groups in social, economic, cultural and political spheres;
- > To undertake theoretical and empirical research on the consequences of exclusion in multiple spheres on the denial of rights and entitlements, particularly focusing on economic growth and development, inter-group social inequalities, poverty, deprivation and marginalisation;

- > To study the dynamics of institutions of social exclusion and the processes causing change;
- To provide evidence based policies to government, civil society organisations and donor agencies for developing, formulating, and evaluating policies and provisions for marginalised social groups to overcome the consequences of social exclusion;
- > To study the collective actions of marginalised groups, for example, political activism, NGO movements, literary and art movements, and discriminated women's movements;
- To provide knowledge support to civil society organisations engaged at local, regional, national and international levels in 'advocacy works' for the empowerment of discriminated and excluded communities;
- > To develop an extensive database on social groups in India and serve as a resource centre for academicians, researchers, activists and others;
- > To strengthen networking with like-minded institutions, both in India and abroad, for greater sharing of information and ideas through collaborations and partnerships; and
- > To organise seminars, workshops, roundtable discussions and lectures of academic and policy interests with contemporary relevance.

#### **Areas of Research**

The issue of social exclusion along with its consequence on poverty, economic and social development and the remedies to overcome it is an area which has generally found lesser space in the mainstream social science discourse. At the same time, there has been a growing demand among the social groups for group-specific policies. Lack of understanding on these issues has constrained the capacity of government and civil society organisations to develop appropriate policies. The primary focus of IIDS, therefore, is on developing a scientific knowledge base on the issues of social exclusion, marginalisation and discrimination through intensive research. As the research agenda of the Institute is multidisciplinary in nature, it undertakes research on thematic areas like social exclusion and discrimination, human rights and deprivation, human development, poverty, policies for inclusive development and other development concerns of various marginalized groups like Dalits, tribals, religious minorities, women (particularly belonging to excluded groups), persons with disabilities, denotified and nomadic tribes and others.

#### **Reasearch Units**

IIDS has six research units formed on the basis of thematic areas and social groups.

- i. Social Exclusion and Discrimination Studies —focuses on the nature, dimensions and consequences of various forms of social exclusion. More specifically, the focus of the unit is primarily on (a) understanding the nature of social exclusion in social, economic, political and cultural spheres of society, associated with the institutions of caste, ethnicity, religion, gender, colour, disability, regional identity, and age; (b) understanding the consequences of social exclusion on human development and well-being, human rights, human dignity, etc; and (c) developing evidence based policies for developing a socially, economically and politically inclusive society which is free from any form of exclusion and discrimination.
- ii. Gender and Social Exclusion Studies—focuses on discrimination, social exclusion and deprivation among women from socially excluded groups like Dalits, scheduled tribes, backward classes and religious minorities. The need to address gender issues with the social exclusion lence was exclusively felt as women particularly from the socially excluded communities are more vulnerable, and the issues at hand are too large to encapsulate it under an umbrella term.
- **iii. Tribal Studies** focuses on understanding the development paradigm of tribal communities in the context of their vulnerability, discrimination, deprivation, poverty, human rights, and endangered livelihoods associated with development, apart from the study of institutions that govern tribal development.
- iv. Religious Minority Studies —focuses on the issues of vulnerability, discrimination and deprivation among religious minorities and further examines the programmes for their development, empowerment and inclusion in governance and society
- v. **Policy Studies** –undertakes evaluation of policies and programmes of government and other donor agencies relating to livelihoods, poverty, social protection, economic empowerment, human development and human rights. It also provides policy inputs to

- policy makers on the issues of removing caste based discrimination, social exclusion and promoting development programmes for socially excluded groups towards attaining inclusive growth.
- vi. Dalit Literature and Arts— focuses on publishing literature on Dalit leaders who have contributed towards social movements or established educational institutions for Dalit children, etc., either at national or regional level. It also focuses on reviving the various art forms among the Dalits so as to bring back the social status of Dalit artists. These research output are published in Hindi and other regional languages.
- vii. Dissemination and Outreach—focuses on wider dissemination of IIDS research output and provides a forum for debates and discussions on issues relating to exclusion, discrimination and promoting inclusive society. The unit delivers relevant and accurate information to funding agencies, policy makers, academicians and human rights activists working on the issues of social exclusion and discrimination. The unit coordinates a network of academicians, researchers and activists all over the world to provide a plethora of information on socially excluded groups.





#### III. RESEARCH PROGRAMMES & PROJECTS

#### Completed Research Projects in 2010-11

IIDS completed ten research projects in 2010-11. Of these, six projects were completed under the International NGOs Partnership Agreement Programme (IPAP) titled "Social Exclusion and the Dalits: Programme for Research, Knowledge, Empowerment, Training and Advocacy". The programme is supported by Christian Aid, UK. The other completed research projects were funded by IDRC, Canada, Justice and Peace, Netherlands and International Food Policy Research Institute (IFPRI), USA. The summaries of the research studies are presented below:

i. Programme on Dalit Women Rights and Citizenship in India. Completed by *Gender and Social Exclusion Studies Unit*, with support from IDRC. (Researchers: Nidhi Sadana Sabharwal, with input from Wandana Sonalkar, Anupama Rao, Vimal Thorat, Vani Booroah, Narender Kumar and Parimala.)

This study focused on the problem of 'Dalit women' in India. This was done through a comprehensive review of the current theoretical and empirical literature related to feminist discourse on gender and patriarchy and Dalit women in particular. The study examined (a) feminist discourse as developed in social science literature and capture its main elements, (b) Indian feminist discourse and its understanding about the problems of Dalit women, (c) various forms of deprivation that Dalit women suffer in the light of the rights of the citizenship, (d) the perspectives of Dalit women writers as well as of other writers on the problems of Dalit women (e) the economic and social situation of Dalit women based on official data as well as empirical studies, and (f) the agenda for further primary studies on various dimensions of problems of Dalit women..

ii. Mapping Caste-based Atrocities in India with a focus on Dalit Women. Completed by *Social Exclusion and Discrimination Studies Unit* under the IPAP programme, with support from Christian Aid, UK. (Researchers: G.C. Pal and L. David Lal)

This study focused on specific issues that could not be addressed in earlier report on caste atrocities. for a holistic understanding of castebased atrocities in India. The specific issues covered in this report were (i) strengthening the literature on caste atrocities from an interdisciplinary perspective; (ii) examining the patterns and trends of atrocities against Dalits with special focus on regional variations at state and district levels; (iii) analyzing recent media reports and fact findings on atrocities against Dalits to understand the pattern of caste atrocities in recent years; iv) analyzing the nature and patterns of atrocities especially against Dalit women and the role of various non-governmental organisations and women organisations in addressing the issues: (v) studying the role and functions of local administrative mechanisms and national level organisations such as NHRC, SC/ST Commission, NCW, etc, with regard to atrocities against Dalits (vi) understanding the emerging issues based on collation of views of various stakeholders on various aspects of atrocities against Dalits. .

iii. Dalit Christians in India: Discrimination and Inter-group Disparities in Human Development. Completed by *Religious Minority Studies Unit* under the IPAP programme, with support from Christian Aid, UK. (Researcher: Sobin George)

The study explored whether caste has been a defining marker of social and economic relationship under Christianity and concluded that even after conversion, characteristics of caste such as endogamy, residential segregation, restricted social interaction, hierarchies, caste-based occupation and graded ritual purity or pollution were reproduced in one way or the other among the converted Christians. Persistence of local traditions, largely Hindu traditions among Christians also points to the fact that conversions had not significantly changed the existing structures of caste system. As a result, the identity of converted Dalits more or less remained the same in the larger society as well. In most of the cases, converted Dalits were still tied up with their caste and traditional occupations as agriculture workers in the lands of upper castes. This reinforces the local power relations, which in a way propagates the existing caste practices. As a result Dalit Christians often become subject to discrimination, slavery, bondage, atrocities and economic exploitation, yet the legal safeguards against untouchability,

discrimination and atrocities are not extended to them since they do not fall in the official category of Scheduled Castes.

iv. Dalit Muslims in India: Discrimination and Inter-group Disparities in Human Development. Completed by Religious Minority Studies Unit under the IPAP programme, with support from Christian Aid, UK. (Researcher: Aftab Alam and Martin Kamodang)

The study examined the practice of caste system among the Muslims in India, drawing on evidence from the social science literature on the forms of discrimination and social exclusion that Dalit Muslims face. It includedvarious modes of subordination in places like mosques, burial grounds and restrictions on marriages, besides occupational segregation and economic exploitation. The study also examined the Dalit Muslim politics and its assertion for granting Scheduled Caste status to them. Apart from presenting the socioeconomic conditions of Dalit Muslims, it also looked into the development profile of Dalit Muslims by examining their education status, occupation patterns, employment and unemployment and poverty situation to establish the inter-group as well as inter-religious disparities in human development. The study showed that incidence of poverty was highest among Dalits in all occupational categories in rural India. In urban India, Dalit Muslims were more poor than other groups, except OBCs, in the category of casual workers. Similarly, the share of 'poor and illiterates' was the highest among Dalit Muslims in rural India. In urban India, the share of 'poor and illiterate' was the highest among OBC Muslims followed by 'others' and Dalit Muslims. The study concluded that Dalit Muslims like other Dalit groups suffer from a development deficits, which justifies groupspecific policy interventions for their upward mobility.

v. In the Footsteps of Ambedkar: Mobility, Identity and Dalit Initiatives for Change. Completed by *Social Exclusion and Discrimination Studies Unit* under the IPAP programme, with support from Christian Aid, UK. (Researcher: Surinder S. Jodhka)

The study examined the articulation and imagination of Dalit identity by the middle class urban activists working in and around the city of Delhi. The study revealed that a majority of Dalit activists of Delhi were men in the age group of 31-50 years. Most of them hailed from

the northern states of India, especially from Uttar Pradesh. A large number of them identified themselves as Chamars or Jatavs, followed by Valmikis and related castes. Although caste falls under the tenets of Hinduism, only a small proportion of them (13.6 per cent) chose to identify themselves as Hindus. Most of them identified themselves either as Buddhists (48 per cent) or atheist (31 per cent). The proportion of Christians was also not insignificant (7.4 per cent). Many of the respondents were from second or third generation of mobile Dalit families and were well educated and not involved in their traditional caste occupation. Nearly 95 per cent of them placed themselves in the broad category of 'middle classes'. The study also found that the identity of 'Dalit' was not universally accepted as a category of self-description and no one liked to be called a Harijan. The study also spawned an extremely rich description of discrimination and social exclusion the Dalit activists faced in the recent past. The pressing agenda for them was social transformation of the caste order.

vi. Tribals in India: A Status Report. Completed by *Tribal Studies Unit* under the IPAP programme, with support from Christian Aid, UK. (Researchers: R.P. Mamgain, Firdaus F. Rizivi and G.C. Pal)

The study presented an overall socio-economic status of Scheduled Tribes in India within the framework of exclusion, discrimination, and deprivation, based on available secondary data and literature. The study was engaged with the issues of tribal demography, access to basic civic amenities, health status, ownership of agricultural and forest land, occupational patterns, employment conditions, incidence of poverty, literacy and education, displacement due to development projects, atrocities etc. The study found that despite various development initiatives aimed at improving the overall conditions of tribal communities, they continue being marginalised and live under chronic economic distress, largely owing to poor planning and implementation of development programmes and political apathy. This report serves as a comprehensive analytical tool for understanding the changing dynamics of contemporary tribal society for academicians, policymakers, human rights activists and other stakeholders on tribal development issues.

vii. Dalit/Tribal Biographies: Sankar Bhivasan Chavhan: The Travel of Struggle and Movement of Nomadic Tribes in Maharashtra (Both in Hindi and Marathi). Conducted by Dalit Literature and Arts Studies Unit under the IPAP programme, with support from Christian Aid, UK. (Researchers: Dalip Katheria in Hindi and Ashok Pawar in Marathi).

This study was based on extensive field research looked into the life of one of the prominent tribal activists, Sankar Bhivasan Chavhan (1935-2000) from Beldar nomadic tribe in Maharashtra. The prejudice against nomadic tribes as 'criminals' led Sankar Bhivsan Chavhan to contemplate on the issues raised by Dr. Ambedkar and initiated work against this social bias. Challenged by his involvement in such issues, he was ultimately ostracised from the community by the Panchayat. This study would help in understanding Sankar Bhivasan Chavhan's struggle for social justice and his contribution to empowerment of nomadic tribes.

viii. Dalits and Land Rights in India: A Case Study of Land Grab in Orissa and Andhra Pradesh. Completed by Social Exclusion and Discrimination Studies Unit with support from Justice and Peace, Netherlands, (Researchers: Motilal Mahamallik and Martin Kamodang)

This study tried to capture the types of impunity involved in the process of land grabbing from Dalits in Orissa and Andhra Pradesh. The study dealt with two important issues: a framework for the analysis of land grabbing within the human rights parameter and institutional responsibility in the process of land grabbing. It included introduction to the cases of land grabbing, nature and process of land grabbing and ethnographic analysis of land grabbing in the states. The analysis was based on primary data collection from different stakeholders. A structured schedule was used to capture the process of land grabbing for the selected 60 cases, and documents such as rent receipt, revenue receipt, application letters, FIR, land pattas, etc, relating to each case from both officials and non-official sources were collected. The documents provided the details on possession of land holding, perpetrators information, and other details.

ix. Socio-economic Background of MLA's from 16 Major States of India. Conducted by Social Exclusion and Discrimination Studies Unit with support from International Food

Policy Research Institute (IFPRI), Washington DC, USA. (Researchers: Sukhdeo Thorat and Firdaus F. Rizvi)

This study was part of the research programme on "Political Factors, Government Spending and Agriculture Growth and Poverty Linkages" sponsored by IFPRI, USA. The project compiled data on the socio-economic background of Members of Legislative Assemblies (MLAs) from 16 states of India. The data collected included religion and caste backgrounds of MLAs, their constituencies, political party from which they contested election, education, profession and age at the time of election from 1951 to 2004. The states covered under the study are Andhra Pradesh, Assam, Bihar, Gujarat, Haryana, Himachal Pradesh, Jammu & Kashmir, Karnataka, Madhya Pradesh, Maharashtra, Orissa, Punjab, Rajasthan, Tamil Nadu, Uttar Pradesh and West Bengal. The study analysed how social factors like caste, culture and ethnicity of these MLAs determine exclusion and persistence of poverty among the marginalised sections of the society.

# x. Social Structure and Educational and Employment Achievements: A Study of Disparities across Different Social Groups in India (1983 to 2004-05). (Resarchers: Veronica Pala and Amaresh Dubey)

This study analysed the disparities across social groups in terms of employment and educational achievement. It is based on the NSSO quinquennial survey data on employment and unemployment for five reference periods during 1983-2004-05. In specific terms, this study examined disparities in (i) labour force participation across social groups; (ii) employment and unemployment situation across social groups; (iii) extent of underemployment across social groups; (iv) occupational structure and (v) wage rates across regions and gender for various social groups. The study revealed poor quality of employment along with high incidence of unemployment and lower educational level as a persistent disparity in case of SC and STs as compared to 'other' groups. This has resulted in overall low earnings and high incidence of poverty among SCs and STs. The findings of the study, thus, bring forth major policy implications for improving the employment and educational opportunities for these groups.

#### **Ongoing Programmes & Projects**

There are three on-going research programmes, which comprise several research projects.

- Research projects under the Programme on Social Exclusion and the Dalits: Programme for Research, Knowledge, Empowerment, Training and Advocacy, supported by the IPAP Programme of Christian Aid, UK
  - i. **Mapping Caste-Based Atrocities in India with Special Reference to Uttar Pradesh.** Conducted by *Social Exclusion and Discrimination Studies Unit.* (Researchers: G.C. Pal and L. David Lal)

This study, as a follow up to earlier studies on "Mapping Caste Atrocities in India", attempts to examine the pattern of caste based atrocities in India in the year 2011 and the wide range of critical issues on caste-based atrocities in Uttar Pradesh to strengthen the understanding of the complex problem of caste atrocities in specific context. The scenario of atrocities against Scheduled Castes in India points to widespread violation of human rights. The socio-political context of the incidence of caste-based atrocities in the state of Uttar Pradesh has raised many questions on the is she of governance and state machineries dealing with atrocities. According to official data, Uttar Pradesh leads in terms of magnitude, pattern and disposal of caste-based atrocities. The specific objectives of the study are to: (i) examine the overall pattern of caste atrocities in India in the year 2011; (ii) examine the pattern and trend of caste-based atrocities in Uttar Pradesh; (iii) examine the diversity in caste-based atrocities in the state in terms of areas, gender, forms of crimes etc.; (iv) understand the responses of state administrative and judiciary mechanisms dealing with atrocities; (v) understand the role of civil society organisations in the state with regard to caste atrocities; (vi) document state-specific measures in curbing the caste-based atrocities; and (vii) suggest policy directions on caste-based atrocities. The study will draw from micro-level data available from fact finding reports, media reports, institutional documents and experiential accounts of the non-governmental organisations working on atrocities in the state, victims of atrocities and other stakeholders.

ii. Local Governance in Tribal Areas: A Comparative Study of PESA Implementation. Conducted by *Tribal Studies Unit*. (Researchers: Martin Kamodang, C. R. Bijoy and Mithika D' Cruz)

The main objective of the study is to draw a comparison of local selfgovernance in those Fifth Scheduled Areas where Panchayat Extension to Scheduled Areas (PESA) Act is implemented and also those areas where it is not implemented and also show how traditional leaders are settling disputes, managing land alienation and land acquisition, water bodies, minor forest produce and regulating village market, mining leases and licenses for the welfare of tribal households in both the contexts. It will also examine how tribal households are granted rights over both private and common land, minor forest produce and water bodies and analyze their access to it in both the areas. This study also strives to understand what is offered to the tribal people through 'devolution' in PESA Act and how such provisions are implemented at the village level. Other questions the study will address are: What are the mechanisms developed by them to manage natural resources? How have Panchayats and Gram Sabhas been able to protect and conserve their customs and traditions? Despite the act being operational for more than a decade, there is lack of information on the status of its implementation. Though there have been several movements and voices against the non-implementation of PESA, their experiences as well as that of the government agencies have not been documented nor have they been subjected to systematic research. Therefore this research study proposes to fill the data gaps for policy recommendation and also to be used as a tool for advocacy.

## iii. Evaluation of Affirmative Action Policy in Private Sector. Conducted by Social Exclusion and Discrimination Unit. (Researchers: Firdaus F Rizvi and Sukhadeo Thorat)

Although several private sector companies are signatories to affirmative action policy, the result of such measures in promotion of employment for SC/ST is yet to become visible. SCs/STs still remain under-respresented in terms of their share in the private sector employment. Moreover, the achievements and failures of the affirmative action are not well documented for informed policy advocacy. Therefore, this study proposes to critically evaluate the

working of the affirmative action policy, adopted by leading private sector companies since 2007 and further analyses how it has impacted on the quality of the life of the socially marginalized groups (SC and ST). The specific objectives of the study are: (1) to provide an overview of the affirmative action provisions adopted by major chambers of the industries in the country (2), to examine the implementation of affirmative action policy by those member organisations/industries that offer affirmative action, (3) to evaluate the impact and consequences of affirmative action policy on SCs and STs, and (4) suggest policy for effective implementation of affirmative action policy for these groups in private sector.

**2.** Research studies under the programme, *Social Inclusion in Multiple Spheres (2009–2011)*, supported by UNICEF.

Under this programme there were four studies based on a large field survey in three states of Uttar Pradesh, Madhya Pradesh and Karnataka, as follows

i. Study of the Dynamics and Processes of Exclusion and Discrimination in Maternal and Child Health Services among Dalits and Minorities. Conducted by Social Exclusion and Discrimination Studies Unit. (Researchers: R.P. Mamgain and Sanghmitra S. Acharya)

The study is an analytical exercise to understand the levels, process and dynamics of exclusion experienced by Dalits and Minorities (Muslims) with focus on the Maternal, Neonatal and Child Health (MNCH) services, one of the major health programmes for women and children in India. Though there is macro level data available on accessibility of health services across social groups, such data do not bring out the levels, dynamics and processes of inequities or reveal the nature and forms of exclusion experienced by these groups. Besides understanding exclusion of Dalits and minorities from health services in specific and comparative contexts, the study will also help comprehend the levels and processes by which Dalits and minorities are excluded from the MNCH programme and provide policy suggestions for their inclusion.

ii. Inclusion in Integrated Child Development Services (ICDS) (Conducted by Social Exclusion and Discrimination Studies Unit. (Researchers: G.C. Pal and R.P. Mamgain)

The Integrated Child Development Services (ICDS) is a major national welfare programme to protect the basic rights to pre-school education, healthcare and nutrition of children below the age of six years. The programme is implemented through vast network of Anganwadi Centres (AWC), with particular focus on the underprivileged groups like SC/ST and Muslims. This study focuses on the role of AWCs in the protection of rights of children within the framework of service delivery mechanism and also the implementation process of the ICDS programme with specific focus on the issue of discriminatory practices in the implementation of the programme for the children below six years. The study proposes to address the following issues: How far AWCs are able to protect and promote the 'positive freedoms' of children below six years? Do all the children irrespective of caste, religion, class, etc. have access to services provided by AWCs? Are the children of all social groups treated fairly in the process of implementation of the programme? To what extent Dalits and Muslims have 'a meaningful participation' in the implementation of programme? What problems AWCs face in the implementation of the programme and also the problems in addressing the needs of children? What are the best practices of inclusion in the implementation of the programme? The study, thus, focuses on availability, access, participation and treatment with regard to children of Dalits and other socially disadvantaged sections, in the process of implementation of nutrition, health and education services under the ICDS scheme.

**iii. Inclusion in Total Sanitation Campaign.** Conducted by *Social Exclusion and Discrimination Studies Unit.* (Researchers: R.P. Mamgain, P.M. Kulkarni and Soumya Kapur)

Total Sanitation Campaign (TSC) was launched in 1999 by the Department of Drinking Water Supply, under the Ministry of Rural Development, Government of India. Data shows that lack of sanitation facilities have led to loss of lives among children and adults, particularly in rural areas. Most of these victims belong to SC/ST and Muslim communities, who live in poor health and hygiene conditions. This research study focuses on the extent to which TSC is community-led and community-driven and also how inclusive is the programme for the marginalised communities, especially Dalits, Adivasis Muslims. This study aims to address the access and

participation of these communities, identifies gaps in the service delivery, and assesses the role of TSC in strengthening social inclusion of these communities. It also strives to understand an accurate, current and ground level view of how, where and to what extent discrimination and exclusion operates in the TSC programme.

iv. Policy and Best Practices of Inclusion in Health, Education, Water and Sanitation. Conducted by Gender and Social Exclusion Studies Unit. (Researchers: Sukhadeo Thorat and Nidhi Sadana Sabharwal)

This study maps out the best practices being followed in the implementation of food security, nutrition, health, education and sanitation with an objective to develop inclusive policies that can safeguard these groups from susceptibility to exclusion, discrimination and poverty.

#### Summaries of Independent On-going Projects

1. Political Factors, Government Spending and Agricultural Growth and Poverty Linkages, Phase II (Conducted by Social Exclusion and Discrimination Studies Unit with support from International Food Policy Research Institute (IFPRI), Washington DC, USA. (Researchers: Sukhadeo Thorat and Firdaus F. Rizvi)

The long term trend over a 50-year period (from 1951-52 to 1990-2000) reveals three distinct phases, namely early 1950s-1970s during which poverty fluctuated without any clear trends. Secondly, 1970-1990s where a steady reduction in poverty occurred and lastly the 1990s during which the poverty tended to decline faster. It is in this context, the study focuses on the extent to which political factors and government policies have an impact on agricultural growth and poverty reduction during a pariod of five decades since Independence.

2. **Dalit Women in Indian Politics: Making Impact through Parliament.** Conducted by *Gender and Social Exclusion Studies Unit* with support from International Development Research Centre (IDRC), Canada. (Researchers: Nidhi Sadana Sabharwal and L. David Lal)

This proposal builds on the previous IDRC supported research support project on Dalit women rights and citizenship in India which presented selected evidence on the nature and forms of caste-based discrimination suffered by Dalit women in access to sources of livelihood, social needs and political participation. The proposed research project focuses on political participation and representation of Dalit women in India by understanding the level of participation, representation, and role in national government including cabinet, parliament and ministries.

4. Study on Social Exclusion and Poverty Linkages: A Study on General and Discriminated related Factors Determining Access to Government Schemes for Employment, Agriculture Land, Forest, Health and Food. Conducted by Gender and Social Exclusion Studies Unit with support from DFID, UK. (Researchers: Sukhadeo Thorat, Nidhi Sadana Sabharwal, Karimullaha and Dilip Diwakar)

This study proposes to identify different forms and nature of discrimination in the Schemes/Acts targeted under flagship schemes i.e. MNREGS, Scheduled Tribes and Other Traditional Forest Dwellers (Recognisation of Forest Rights) Act, 2006 (FRA), Revenue Land, Janani Surakshya Yojana (JSY), ICDS and Mid-Day Meal Scheme (MDM) in PACS focal states. Further, this study will analyse whether the provisions of the Acts/Schemes are sufficient and sensitive to ensure non-discriminatory access to all social groups. This study will be carried out in selected districts of the seven PACS targeted states. It will examine discrimination in terms of caste, ethnicity, religion, gender and disability. The study will provide an in-depth knowledge and understanding on different aspects of discrimination and illustrate how government Civil Society Organisations (CSOs) can play an effective role in addressing these issues.

5. Social Inclusion and Social Protection of Workers in the Informal Economy and of Vulnerable Groups: A Study in four Countries Afghanistan, Bangladesh, India and Nepal in partnership with ODI, UK. Conducted by Gender and Social Exclusion Studies Unit with support from European Union (EU). (Researchers: Nidhi Sadana Sabharwal, Ajaya Kumar Naik and Kaniyha Singh)

The study focuses on generating a solid evidence base on the extent to which social protection is (or isn't) effectively reducing poverty among groups of the poorest — specifically informal workers but also other vulnerable groups. It will effectively use this evidence to influence national social protection policy and programming in the four countries. It will draw relevant policy and implementation lessons for regional and international audiences on how social protection can support progress towards poverty reduction and social inclusion for informal workers and vulnerable groups in rural and urban areas across stable, fragile and post-conflict countries. In India, the study will assess the effectiveness of the Rashtriya Swasthya Bima Yojana (RSBY) on the access and utilisation of health services by the informal workers, specifically from SC/ST groups. The study will also probe to what extent the RSBY programme has succeeded in minimising the extent and form of social discrimination.

#### **IIDS Library**

IIDS library is an exclusive research and reference library with a sizeable collection of books, government documents and publications. Besides books on various social science subjects, the library has a substantial collection of statistical publications and survey reports, for example, National Sample Survey Organisation (NSSO), National Family Health Survey (NFHS), Population Census, Economic Census, and Economic Survey. The library has a collection of about 950 books and 750 reports on various subjects, including a comprehensive collection on Dalits and Dr. B. R. Ambedkar. A number of working papers and discussion papers of other organisations and institutions are also available. The library is widely accessed by academics, researchers and activists from India and abroad. All the library functions are fully automated using library management software (KOHA). Bibliographical details of library collections are accessible through Online Public Access Catalogue (OPAC) within LAN.

#### **Data Support**

Dalit studies in India suffer from paucity of data and also from lack of a centralised database. IIDS has created Data Unit and Documentation Centre with the capacity of processing and analysing large data sets, both primary and secondary data from NSSO, NFSH, etc, for facilitating research. Besides, data are also available on various aspects related to marginalised communities in India. IIDS has developed a detailed all-India and state level database for Scheduled Castes, Scheduled Tribes, Other Backward Castes, and other religious groups. These data have been widely used by academicians, students, government agencies, bilateral agencies, national and international NGOs, activists and others.

IIDS website is one of the major channels of dissemination of its research output. Abstracts of books, working papers and details of research programmes are available and accessible on the website.
